Admission to Semester-I of the Three Year B.C.A. Course shall be open to a Candidate having passed the Higher Secondary Part-II (10+2 Pattern) examination (in full subjects) of the Jammu and Kashmir State Board of School Education, CBSE or an examination recognized as equivalent thereto with <u>Mathematics</u> as one of the elective subjects and has obtained at least 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST candidates.
